7. That, the bio-degradable waste shall be processed, treated and disposed off through compositing or bio-methanation within the premises as far as possible. The residual waste shall be given to the waste collectors or agency as directed by the local body;

8. That, the Operator shall comply all the provisions of the Bio-medical Waste Management Rules, 2016.

9. That, they will ensure regular operation of OCEMS system with proper connectivity with CPCB and SPCB servers.

That, they shall monitor his/their emission(s) and the ambient air quality from 3. representative point regularly and shall maintain its quality in conformity with Board's standards and shall produce its proof, as and when asked for;

That, they shall submit application for consent again 30 days before the expiration of 4. the period of consent.

That, the occupier shall submit stack emission report every six month during the 5. period of consent order.

That, the D.G set should be provided with an integral acoustic enclosure and the 6. maximum permissible sound pressure level for new D.G set shall be 75dB(A) at 1 meter from the enclosure surface.

That, the minimum height of stack for exhaust emission to be provided with D.G set 7. shall be 1.0 meter more than the height of the building where it is installed.

That, the unit shall maintain Online Stack Emission Monitoring System. 8.

That, the unit shall submit Environmental Statement by Sept. every year;

10. That, tree plantation shall be done in space available in the complex;

That, the operator shall comply all the conditions as imposed in the Authorisation 11. under the Bio-medical Waste Management Rules, 2016

That, the unit shall submit Annual Report in Form -IV under the Bio-Medical Waste 12. Management Rules, 2016 to the Board within 30th June every year;
